easy movement of fire appliances. 2.No parking will be allowed on the drive way. 3. A Fire control room including a closed circuit tv system will be maintained which observe all floor of the building. 4.miminum 4no ABC (6.5 kg) and 2 no CO2 (4.5kg) fire extinguisher shall be kept at each floor . 5. Provision of anther hose reel system conjunction with the down comer shall be made at each floor level as such that no part of the protect floor is more than 6m. 6. The employees and security staff shall be conversant with fire fighting equipment of the building and to operate in the event of fire and testing. 7.A crew of trained fire men under the experienced officer shell be maintained round the clock for safety of the building. 8.The Fire safety audit to be conducted a regular interval and to be recorded in the fire prevention maintenance register . 9. Directional sign of escape route shall be displayed prominently. 10. Recommended standby pump to be installed 5HP instate 3.5 HP within six month. 11. No deviation change of this building without the prior permission of this department otherwise this RFSC treated as cancelled. 12. This RFSC is valid for three years and has to be renewed every three years from the date of issue of this letter.
